Travel Insurance:

Travel Insurance is highly recommended. Cancellation fees begin at \$150 and reach 100% of your trip cost after final payment. Because of this we offer Travel Insured Deluxe Plan, the coverage limits and prices are listed below. Because there is no age limits, the cost is significantly lower than other insurance companies. Also, because this is group coverage, the pre-existing existing condition exclusion is waived provided the protection plan is purchased prior to making the final payment or purchasing a non-refundable air ticket, whichever comes first.

The Trip Cancellation/Trip Interruption covers you if you are prevented from taking or continuing your covered trip due to the following unforeseen events:

- a. **Sickness**, injury or death involving You or Your Traveling Companion, or You and Your Traveling Companion's Business Partner or Your Family Member; which results in medically imposed restrictions as certified by a Legally Qualified Physician at the time of loss preventing Your continued participation in the Trip.
- b. **Unannounced Strike** that causes complete cessation of services of Your Common Carrier for at least 24 consecutive hours.
- c. **Weather** that causes complete cessation of services of Your Common Carrier for at least 24 consecutive hours.
- d. **Employer termination** or layoff affecting You or a person(s) sharing the same room during Your Trip. Employment must have been with the same employer for at least (3) consecutive years.

If these fees increase or if a fuel supplement is reinstated by the cruise line due to an escalation in the price of fuel, the cruise line is legally obligated to collect these fees at final payment. It is the full intention of each quilting instructor and cruise coordinator contracted to participate on this cruise to personally participate on this cruise. However, in the event that unforeseen circumstances beyond the control of the individual quilting instructor, and/or the cruise coordinator, which could include a medical or immediate family member emergency, being physically unable to participate, or a serious incident requiring their presence elsewhere occurs and prevents them from personally participating on this cruise, it is to be understood by all who register for the cruise that these circumstances shall not constitute justification for invalidating the cruise passage and the full extent of liability on the part of the quilting instructor, and/or the cruise organizers shall be limited to continuing to provide cruise participants with the classes taught by a qualified instructor or a refund of class and kit fees paid directly to the instructor, parties, special events, a qualified group escort representative of Quilt Camp at Sea and/or Travel Leaders/Travel Center, Inc. and materials promoted as being provided by the cruise organizers that are included in fares. In the event an instructor's participation on this cruise is cancelled due to limited enrollment of class participants and you have registered for that instructor's class, you will be refunded any class/kit fees you have paid to the instructor and you will be offered a different choice of class based upon availability at that time. Quilt Camp at Sea will not sell the mailing list of cruise participants on this cruise.
